Coffective Update	<p>Outagamie County finishing the last section of the modules. Beth needs to coordinate with the hospitals. Thedacare has done the survey through the state. Sam said they are looking at the PowerPoint platform for training. Sam is the person coordinating the training along with Mary Jo Biederman. Amy Bardon is the manager of both Appleton and Neenah Thedacare Hospital Birth Centers. Solution at present for visitors is if someone is at the City building for city business then the meeting coordinator is the one who schedules the lactation room for them. Jess and Becky said they are also working with Pfeffeler the company that owns City Center about creating a lactation space for public use.</p> <p>One of the group members worked at Timber Rattlers and said they made a lactation room out of an old bathroom and it was basically a chair and a little table.</p> <p>Outagamie County – Cindy and Jo Ellen met with Human Resources staff and discussed the Breastfeeding Friendly Worksite. They were very receptive and within a couple of weeks all of the sites except 2 had a space. Our HR was very pleased that with in the county there are 5 permanent sites and 3 temporary sites just about ready for worksites designation. The Airport is undergoing remodeling and they plan to include a nice lactation space. HR is updating the county's breastfeeding policy and will have the county board vote on it in August. The group discussed what we designate them with and discussed utilizing a Publisher template from Breastfeeding Friendly Child Care for the certificate.
